The Walk is organised by JusticeNet and all money raised from the Walk will go towards funding JusticeNet's pro bono referral scheme. There are many ways that individuals, firms, businesses and chambers can participate. It costs only \$15 to register for individuals and \$5 for students to register. Individual walkers and teams are also encouraged to obtain sponsorship from colleagues, friends, family and their employers. Referrals

JusticeNet has made 47 referrals to members firms and barristers since inception. We estimate that our members have provided in the order of **\$250,000** worth of pro bono assistance to those in need. Recent referrals that have concluded include:

- DLA Phillips Fox assisted an aboriginal corporation to make a winding up application to the Supreme Court. The application was successful and the order obtained, although there were significant complicating factors that entailed a significant investment of resources by the firm.
- Michael Roder SC successfully represented Mr E, a client of the Welfare Rights Centre in the AAT. Mr E was a farmer in a drought affected area and was in receipt of Exceptional Circumstances Relief Payments. Centrelink reviewed the treatment of income replacement payments received by his wife and identified a significant overpayment. The SSAT made directions in favour of Mr E and the Department applied to the AAT to review the decision. The AAT found in the client's favour and concluded that the amount of overpayment of ECRP claimed by Centrelink should be wholly extinguished.
- Ian Robertson accepted a referral from JusticeNet to assist Ms D with negotiations relating to her equity in the matrimonial home. Ms D's previous relationship was too short for her to rely on the Family Relationships Act 1975, forcing her to rely on equity to establish her claim. Counsel assisted Ms D's solicitor who also acted pro bono. The parties agreed on a division of assets in which Ms D's former partner paid her a sum of money and delivered sundry items to her.
- Gilchrist Connell agreed to help a woman and her two children who were under animal welfare legislation. The women had a mental health condition which made it impossible to defend the matter in person. Gilchrist Connell persuaded the prosecuting authority to drop the charges against the two children, and assisted their client with her plea.

Other referrals that are ongoing include:

- Donaldson Walsh has accepted a referral to provide a charitable foundation with advice on issues relating to the trust funds under its management, and with certain tax compliance issues.
- **Fisher Jeffries** are helping a subcontractor with a dispute with his employer.
- Kelly & Co are assisting a client to defend an application for ejectment.
- Kain C+C have accepted a referral to assist an client challenge the validity of a loan agreement on grounds of undue influence.

- AM Legal are helping out with a wills & estates matter.
- Piper Alderman have taken on a client who has a dispute concerning the validity of a property transfer.
- DMAW Lawyers are assisting a client to defend an action involving the matrimonial home.

Costs in Pro Bono Matters

JusticeNet often refers litigious matters in which there is the real possibility that the client will have a win and therefore be in a position to seek costs. Some might question the appropriateness of a lawyer who is acting pro bono recovering costs – even from the opponent pursuant to a court order – on the basis that the work is done out of a sense of professional responsibility, rather than to earn fees. But why should an opponent benefit from the fact of pro bono assistance to the other side? Or considered from a different perspective, why should the pro bono client alone have to face the risk of an adverse costs order?

While JusticeNet refers matters on the basis that clients are not charged professional fees (we distinguish pro bono from reduced fee arrangements, or what is sometimes known as 'low bono'), we encourage member firms to include a costs clause in their written pro bono retainer agreement that entitles the firm to charge costs in the event of a successful outcome in a litigious matter. Importantly, the clause should be drafted so as to limit the client's liability to the amount taxed under a costs order. In our view, referrals in these circumstances retain their 'pro bono' character because the client is not required to pay for the legal services provided.

An appropriate costs clause might read:

"The firm will not charge for its services, save that in the event that the work that the work is litigious and the work is successful, the firm shall be entitled to charge costs to the client calculated on a party/party basis under [nominate the applicable court scale]. If a costs order is obtained by the client in the proceedings, the solicitor shall tax that costs order and shall accept as full costs the amount taxed under that order and will take not proceedings against the client to recover costs until that order has been taxed."

Costs don't have to be limited to party/party costs, so long as it is clear that the firm will accept as full costs the amount taxed under a costs order (in the event that the firm gets a costs order on an indemnity basis).

JusticeNet encourages member firms to donate any costs they do recover in a pro bono matter to JusticeNet, so as to assist with the continued operation of our referral scheme and other projects. We are happy to discuss alternative arrangements for handling costs on a case-by-case basis, such as when a member accepts the referral of a complex or large-scale litigious matter that may involve significant demands on a firm's resources.

A final word on costs: whatever costs clause you adopt, it is important for members to ensure that clients understand how the contingent liability established by the costs clause operates

Training for the NFP Sector

JusticeNet has identified a need for the provision of low cost legal training for the NFP sector in South Australia. NFPs operate in an increasingly complex legal and regulatory environment, and many have limited discretionary resources for educating and training staff of legal and compliance issues.

We are in the process of developing a seminar series to meet this need. The seminars will be delivered by member and barristers on legal issues that are of particular interest to the NFP sector. The seminars will be held at the premises of our member law firms.

We think that this is an excellent opportunity for firm's to showcase their expertise in this area whilst also making an active contribution to pro bono work in South Australia. We already have two expressions of interest from members firms. Potential topics include:

- · Governance issues and decision making
- Risk management
- Employment law issues
- Intellectual property issues
- OHS issues/managing volunteers
- Tax exemptions and concessions

Similar training programs have been successfully run by our 'sister' organisations interstate (the Public Interest Law Clearinghouses or PILCHs) and well attended by the NFP sector.

National Access to Justice and Pro Bono Conference 2010

The 3rd National Access to Justice and Pro Bono Conference is on 27 – 28 August 2010 at the Sebel Citigate, Brisbane. The theme for this year's conference is *Access to Justice at the Crossroads – Where to Now?*

The conference will cover key issues in the area of access to justice including the case for funding the legal assistance sector, identification of gaps in legal need and improving coordination across the sector.
